### **Public Competition for the Recruitment of 1 International Senior Scientific Investigator for the National Institute of Science and Technology (INCT)**

#### **1. Introduction and Framework**

Pursuant to Government Decree No 6/2015 approving the legal framework for fixed-term contracts in the public administration, the objective of hiring for a fixed term of one (1) International Senior Scientific Investigator, in accordance with the tasks mentioned in the Term of Reference, for the period from 1 August to 31 December 2021 (with the possibility of extension), in the following paragraphs.

#### **2. Place and Service**

The International Senior Scientific Researcher will serve at the INCT office, namely Cabinet of hierarchical superiors, and the Office of Heads of Departments at Avenue of Balide, Dili, Timor-Leste.

#### **3. Application Deadline**

#### **4. Compensation Interval**

The wage conditions offered to the successful candidate are those defined in Table 1, C3, approved by Government Decree No 6/2015 of 18 November, with a maximum monthly gross value of \$6,000.00 (Six Thousand) US dollars.

#### **5. Selection methods and evaluation criteria**

The selection will be carried out through the following steps:

1. 1st step - Curriculum Assessment on 21 July 2021;
2. 2<sup>nd</sup> Step - Professional Interview (Hearing) for candidates admitted in Step 1, who will be informed by e-mail or telephone on 28 July 2021; and
3. 3<sup>rd</sup> Step - Selection of the Candidate by July 30, 2021.


## **7. Formalization of applications**

The application must be submitted by the deadline set out above and must contain the following elements:

1. Letter of Presentation and Motivation (in Portuguese, no more than 3 pages);
2. Curriculum Vitae detailed in PDF format with table of active content for the last 2 years, strictly structured (in Portuguese);
3. A copy of a certificate or a doctorate's diploma;
4. Selection of up to 5 publications (submitted in full and with bibliographical references) or research projects (submitted in full), duly substantiated (with a maximum of 400 words), presented in PDF format, with table of active content.
5. Copy of identity card or passport (Colour); and
6. Other documents which the applicant considers relevant to his/her application.
